UMCOC is pleased to inform you that your application for FADA (Funeral & After Death Assistance) membership has been approved and requested to AUTHORIZE the UNITED MUSLIM COMMUNITY OF CANADA (UMCOC) to draw one-time registration & membership fee and reimbursement share (when and if needed) from your bank account: (confirmation and membership number will be issued within 3-4 weeks

I understand and agree with FADA (Funeral & After Death Assistance) program and policies:

- UMCOC will send an acknowledgement of application Form-A received within 3-5 business days.
- UMCOC will issue a confirmation and membership Form-B within 3-4 weeks.
- UMCOC and members have rights to reject application, revoke or cancel membership and pre-authorized payment anytime with a notice of 30 days.
- A member may cancel membership anytime without receiving of non-refundable registration, membership, and reimbursement share(s).
- UMCOC will provide the funeral and other support to registered members only.
- UMCOC will only pay directly to funeral service provider in Canada against invoices for every deceased member.
- UMCOC will withdraw a reimbursement share, every applicant will pay one full share. Dependant(s) above 25 years will pay only half share per member.
- The reimbursement share will be calculated based on the amount disbursed on funeral related expenses divided among the total number of applicants.
- One reimbursement share will be between CAD1-50, when and if required.
- All applicants will be notified of reimbursement share and will be deducted within 3-5 business days from the applicant's account.
- If any applicant fails to pay reimbursement share for 3 consecutive incidents, UMCOC will revoke the membership and the applicant and member(s) will no longer receive UMCOC benefits until pay all outstanding dues.
- In case of any NSF (not sufficient funds) transaction, UMCOC will charge CAD25 from the applicant to cover bank charges on each NSF transaction.
- The applicant and registered members benefits will be activated after 30 days from the date of application is approved.
- Any beneficiary may apply and claim funeral expenses within 6 months from the date of death against original invoices on the name of UMCOC.
- For a newborn child, the principal applicant must register within one month.
- UMCOC will not be responsible for any special instructions in the WILL against policies.
- Every applicant and/or member must inform UMCOC of change in address within one month. If any member moves permanently outside Canada, membership will be revoked or suspended till reside permanently in Canada.
- UMCOC will not provide services to any applicant and/or member outside Canada.
- All applicants and/or members may choose any cemetery and Muslim funeral organization in Canada for funeral arrangements and need to provide the contact information and prior approved by UMCOC.
- UMCOC have the right to change the policy, notify to the members and every applicant and member to accept the changes in the policy.
